**Renewal of notification for executing profession temporarily and occasionally in Denmark**

The Danish Safety Technology Authority can confirm that Sebastian Placewicz has submitted a new application that he still wants to execute profession temporarily and occasionally in Denmark as the person being technically responsible at the company Eryk Sp. Z.o.o.

We have handled the notification and can confirm that Sebastian Placewicz is still entitled to execute profession in Denmark temporarily and occasionally as the person being technically responsible in the company.

The authorisation number **EFUL-14401** is still applicable for the company.

**Pay particular attention to:**

- the company shall employ at least one authorised person being technically responsible. The professional competences of this person shall be approved by the Danish Safety Technology Authority.
- We are entitled to withdraw the authorisation, if you do not meet the requirements of the authorisation the authorisation shall lapse if the company does not have a person being technically responsible
- You must inform us immediately of any changes of the company address, company form, business foundation, or anything that may become important to the authorisation or person being technically responsible

Sebastian Placewicz shall renew his notification once a year and **at the latest by 6<sup>th</sup> of May 2022** if he still wants to execute the profession temporarily and occasionally in Denmark as the person being technically responsible in your company.

If he has not renewed his notification at the Danish Safety Technology Authority by 6<sup>th</sup> of May 2022, the company authorisation shall lapse. This means that the

company is no longer entitled to do electrical installation work, which requires authorisation in Denmark.
