Renewal of notification for executing profession temporarily and occasionally in Denmark

The Danish Business Authority has received an application from Sebastian Placewicz in which he informs us that he wishes to continue executing his profession temporarily and occasionally in Denmark as technically responsible person in your company.

We can confirm that Sebastian Placewicz is still approved to execute his profession in Denmark temporarily and occasionally as technically responsible person in the company.

The authorisation number is EFUL-14401.

Pay particular attention to:

- At least one technically responsible person must be affiliated with the company for at least 30 hours a week within the company's normal business hours. The professional competences of this person shall be approved by The Danish Business Authority.
- We can revoke the authorisation if you do not meet the requirements of the authorisation. The authorisation shall lapse if the company does not have a technically responsible person affiliated.
- You must inform us immediately of any changes of the company address, company form, business foundation or anything that may be important to the authorisation or the technically responsible person.

Sebastian Placewicz shall renew his notification once a year and **no later than 19th of March 2027** if he still wants to execute the profession temporarily and occasionally in Denmark as technically responsible person in your company.



If he has not renewed his notification to The Danish Business Authority by 19th of March 2027 the company authorisation shall lapse. This means that the company is no longer approved to carry out electrical installations, which requires authorisation in Denmark.

Legal basis

The work shall be carried out in accordance with the requirements of Danish law, Executive Orders and technical regulations in Denmark. It is important that you keep up to date on what your approval includes.

The technically responsible person must be affiliated with the company for a minimum of 30 hours a week within the company's normal business hours. This is stated in § 9 section 1 in the Executive Order on the Authorisation and Operation of Electrical, Plumbing and Sewerage Installation Companies.

The technically responsible person is responsible for ensuring that the company's tasks requiring authorisation are manned properly, that the employees are adequately instructed and that adequate supervision is carried out on the performance of the work. This is stated in § 10 section 1.

The technically responsible person must ensure that the work is carried out in accordance with applicable regulations for electricity, gas, water and drainage installations and in accordance with the company's quality management system. In companies that prepare electrical installation reports, the technically responsible person must also ensure that the work is carried out in accordance with the Executive Order on Electrical Installation Reports as part of the house inspection plan. This is stated in § 10 section 2.
